Coronavirus pandemic

Subject: General decree for coping with considerable numbers of patients in hospitals, etc.

To whom it may concern,

With the general decree for coping with considerable numbers of patients in hospitals (announcement of the Bavarian State Ministry of the Interior, for Sport and Integration as well as the Bavarian State Ministry of Health and Care of 24 March 2020, ref. D4-2484-2-7 and G24-K9000-2020/134), the University Hospital Erlangen was obliged to make existing capacities fully available for inpatient care. In addition, the University Hospital Erlangen must expand capacities for the treatment of COVID-19 patients by all appropriate means.

As a result, the University Hospital Erlangen has largely restricted scientific research work in accordance with its pandemic plan.

In addition, the recruitment of participants for some projects is currently not possible, as no regular medical care is possible due to the general decree and a ban to enter the University Hospital Erlangen (Postponement of elective surgeries and planned treatments in hospitals announcement of the Bavarian State Ministry of Health and Care from 19 March 2020, ref. G24-K9000-2020/125 and general decree amending the general decree on the restriction of visiting rights for hospitals, nursing homes and institutions of the disabled of 13 March 2020, ref. G51b-G8000-2020/122-56).
